Facts	What does FIFTH AVENUE FAMILY OFFICE (Fifth Avenue FO) do with your personal information?
Why?	Financial companies choose how they share your personal information. Federal law gives consumers the right to limit some but not all sharing. Federal law also requires us to tell you how we collect, share, and protect your personal information. Please read this notice carefully to understand what we do.
What?	The types of personal information we collect, and share depend on the service we provide. This information can include, but would not be limited to: your social security number and income; your address and date of birth; and

your account balances and transactions.

How?

Financial companies typically need to share customers' personal information internally to run their everyday business – to process transactions, maintain or service customer accounts, and report to credit bureaus. In the section below, we list why many financial companies can share their customers' personal information, why Fifth Avenue FO chooses to share your information, and whether you can limit this sharing.

Why can't I limit all sharing?	Federal law gives you the right to limit sharing only for

Definitions		
Everyday business purposes	The actions necessary by financial companies to run their businesses and manage customer accounts, such as processing transactions, mailing, and auditing services; providing information to credit bureaus; and/or responding to court orders and legal investigations.	
Affiliates	Companies related by common ownership or control. They can be financial and non-financial companies.	
Non-affiliates	Companies not related by common ownership or control. They can be financial and non-financial companies. • Fifth Avenue Family Office does not share with non-affiliates so that they can market to you.	
Joint Marketing	A formal agreement between non-affiliated financial companies that together market financial products or services to you. • Fifth Avenue Family Office does not jointly market.
